#### **State Laws on Retail CBD Sales**

license to sell low THC hemp-derived CBD products at retail, as long as the person is not processing or manufacturing hemp into CBD The CBD need not be sourced from within Connecticut, but must be legally acquired (“Low THC” means up to 03% THC, on a dry weight basis)

the meat and sell it directly to consumers by the cut in your store and at two other retail locations such as a farmers market or farm stand There are many parameters for what meets or does not meet this exemption In order to meet the USDA FSIS Retail Exemption, you will need to:

### **U.S. Department of Labor Wage and Hour Division**

- the employee works at a retail or service establishment, sold, and your client does not sell large quantities of the platform to any single customer

The fact that your client sells its platform to commercial entities does not change this conclusion; indeed, a business may qualify for the exemption even if it sells “certain products

### **Covering retail sales from**

— Sell cigarettes without a retail license (licenses can be purchased at the local county auditor’s office) — Possess untaxed cigarettes or “other tobacco products” — Traffic in tobacco with intent to avoid tax — Use dyed diesel motor fuel on the highways • Casual Sales are not subject to sales or use tax

RETAIL ESTABLISHMENT A retail establishment is a business in which the majority of food sales consist of beverages or food items requiring further preparation prior to consumption RETAIL ESTABLISHMENTS include, but are not limited to, bakeries, grocery stores, coffee shops, butcher shops
